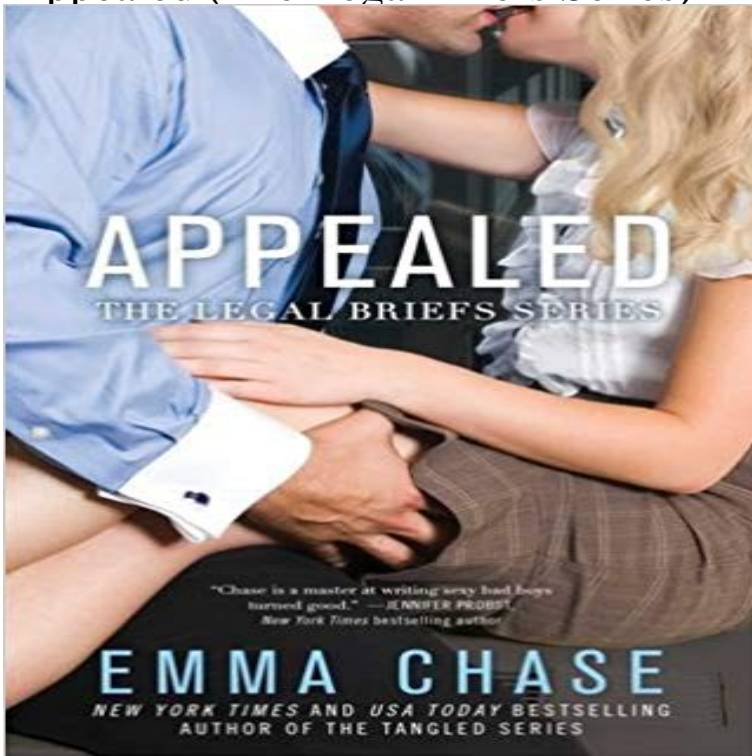


Appealed (The Legal Briefs Series)
