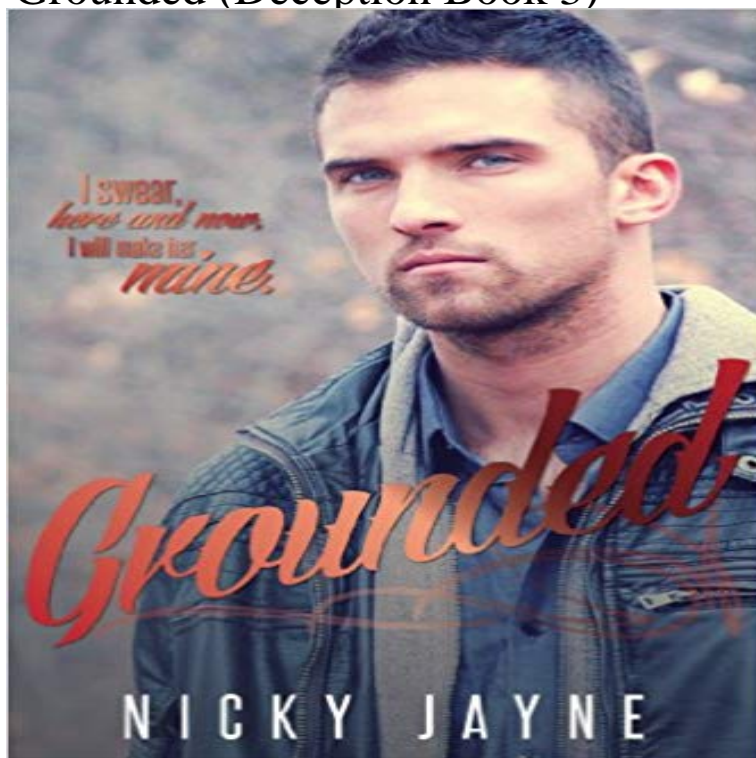


## Grounded (Deception Book 3)
