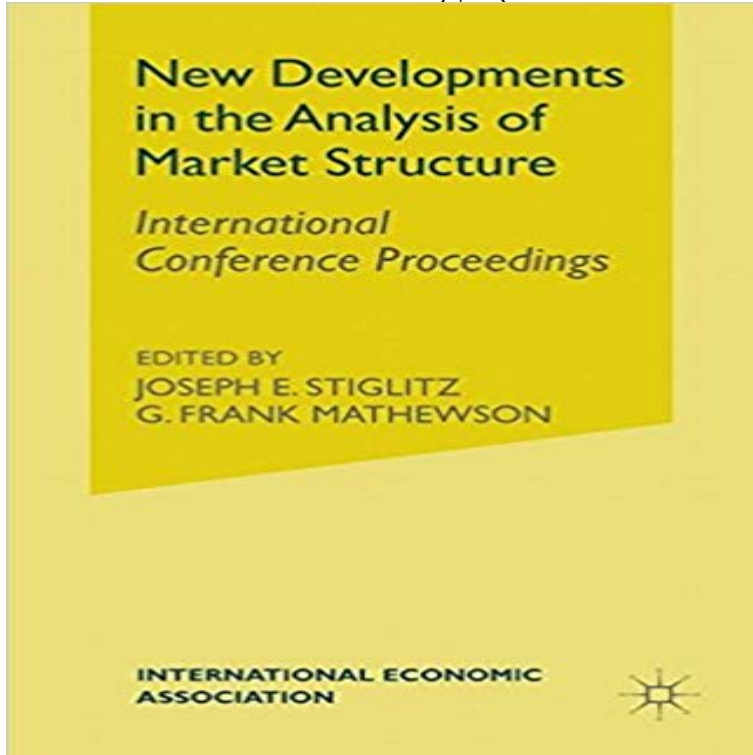


# New Developments in Analysis of Market Structure: International Conference Proceedings (International Economic Association)
